Agency	Types of Premises	Examples (note: examples listed are non-exhaustive)
NEA	Residences	<ul style="list-style-type: none"> <li>• Public housing (HDB), condominiums, landed homes and dormitories.</li> <li>• If cleaning/disinfection works are carried out by third-party cleaning companies for common areas in condominiums and Town Council areas, the scheme applies to them as well.</li> </ul>
	Private offices and private educational institutions or shops in non-retail buildings	<ul style="list-style-type: none"> <li>• Private educational institutions such as enrichment centres, childcare centres, preschools.</li> <li>• Commercial shops such as banks, clinics, hair salons in non-retail buildings etc.</li> </ul>
	Food establishments in non-retail buildings	<ul style="list-style-type: none"> <li>• Restaurants, cafes, foodstalls, coffeeshop, food court, take-away shop, bakery, supermarket, mini-mart, etc.</li> </ul>
	Religious institutions	<ul style="list-style-type: none"> <li>• Church, mosque, temple</li> </ul>
	Recreational facilities	<ul style="list-style-type: none"> <li>• Gyms, country club, bowling alley, etc.</li> </ul>
	Community facilities	<ul style="list-style-type: none"> <li>• Private nursing homes/hospices, clan associations</li> </ul>
ESG	Food establishments in retail malls	<ul style="list-style-type: none"> <li>• Eateries, restaurants, coffee outlets, bakeries, food kiosks, etc.</li> </ul>
	Retailers in retail malls	<ul style="list-style-type: none"> <li>• Apparel shops, bookstores, electronics stores, etc.</li> </ul>
	Other businesses in retail malls	<ul style="list-style-type: none"> <li>• Childcare, clinics, enrichment centres, hair salons, etc.</li> </ul>
STB	Hotels	<ul style="list-style-type: none"> <li>• Licensed hotels</li> </ul>
	Attractions	<ul style="list-style-type: none"> <li>• Museums, amusement/theme park, botanical/zoological gardens, etc.</li> </ul>
	Integrated Resorts	<ul style="list-style-type: none"> <li>• Hotels, MICE venues, and attractions</li> </ul>
	MICE Venues	<ul style="list-style-type: none"> <li>• Singapore EXPO, Changi Exhibition Centre, Suntec Singapore Convention &amp; Exhibition Centre, etc.</li> </ul>
	Cruise terminals	<ul style="list-style-type: none"> <li>• Singapore Cruise Centre, Marina Bay Cruise Centre Singapore</li> </ul>
